The CKWD- BAC reserves the right to reject any or all bid proposals, waive any formality in the bid requirements, declare the bidding failure without thereby incurring any liability to the affected bidder or bidders, or award the contract to the bidder whose offer is the lowest calculated and responsive bid and most advantageous to the government.
