Bidders shall be allowed to conduct physical inspection of the unserviceable properties on **April 12, 2022**, during office hours from **10:00 o'clock in the morning**. However, the bidder shall inform the City of Koronadal Water District Disposal Committee through a written notice prior to the conduct of inspection.

Bids will be opened in the presence of the bidders or authorized representatives who chose to attend at the above mentioned address. Late bids shall not be accepted.

Immediately after the winning bidder has been declared by the Committee, the winning bidder shall pay the full amount of the bid in the form of cash or cheque pay to City of Koronadal Water District within five (5) working days from the date of receipt of the Notice of Award (NOA).
