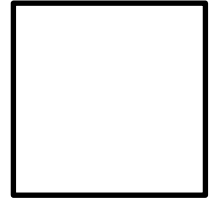

6. A SENIOR CITIZEN CAN ONLY AVAIL OF ONE CONNECTION DISCOUNT.
7. WATER CENNECTION MUST BE RESIDENTIAL.
8. A VALID SENIOR CITIZEN ID MUST BE PRESENTED UPON PAYMENT.
